1. Self-Service Grooming. I release Brookside Barkery and Bath from any and all claims, damages and liability from use of any equipment and facilities. Animal is healthy; bathing senior pets or pets with existing health problems will be at owner's risk. Bathing, Furminating or Grooming may expose pre-existing health/skin problems for which the company cannot be held liable. (See Matted Coat Warning).
2. In the event of any injury or health concern, Brookside Barkery and Bath is authorized to contact a Veterinary and authorize the Vet to treat the pet as necessary. All charges will be at the owner's/Custodians of pet expense. Charges incurred at any Veterinarian, OTHER THAN Brookside Barkery & Bath's VETERINARIAN will not be reimbursed.
3. **MATTED PETS WILL BE SHAVED**
Shaving of pets will dramatically change the pets' appearance and the hair will be **VERY CLOSE TO THE SKIN**. Brookside Barkery and Bath, Inc. will use all precaution during this process. I have been informed and understand possible reactions to shaving such as irritation, nicks to the skin, and pre-existing skin conditions are solely my responsibility for which the Brookside Barkery & Bath cannot be held liable. _____ **Owner's Initials**
4. Anal glands will be expressed externally on small groom dogs upon request. Brookside Barkery & Bath and its' groomers will not be responsible for compacted anal glands or infection due to expressing anal glands.
5. Payment is required at the time of pick up. Owners must pick up pets by designated time or **a \$20.00 late fee will be assessed**. The cost is determined based on the initial bathing/grooming fee plus any additional services or time designated for the pet. _____ **Owner's Initials**.
6. Brookside Barkery & Bath understands that GREYHOUNDS have extremely thin, delicate skin and that even with great care, normal handling might cause a skin injury. The Barkery is released from all costs related to repairing any lacerations during your dog's stay with us. _____ **Owner's Initials**
7. **AGGRESSIVE ANIMALS ARE NOT ACCEPTED. PET GUARDIANS ACCEPT THE RISK OF DAMAGES TO STAFF AND/OR FACILITIES AND REALIZE THAT ANY CLAIM WILL BE CHARGED TO PET OWNER.**
8. If Brookside Barkery & Bath deems necessary, pet will be walked outside on a leash for a break.
9. I hold Brookside Barkery & Bath and/or any agents or employees harmless from any claim for loss of my pet(s) by disappearance, theft, death or otherwise, and from any claim for damage or injury to my pet(s), whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of Brookside Barkery & Bath and/or any agents or employees, or by the negligence of any other person, or any other cause or causes.

I acknowledge that I am completely responsible for the actions of myself and my pet.

Barkery & Bath, Inc. Service Agreement

Barkery & Bath, Inc., (dba Brookside Barkery & Bath) provides high quality grooming, bathing, and pet transportation services ("the Services"). For the purposes of this agreement, the term "Brookside Barkery" refers to our company, its owners, managers, members, agents, employees, and independent contractors. The term "Client" refers to the pet owner and/or property owner who is engaging the Services of Brookside Barkery. The Client's use of Services shall be deemed acceptance of the terms as outlined below.

According to the terms set forth herein, I (Client) _____, direct Brookside Barkery to transport the pet(s) named _____ to the Brookside Barkery facilities for the Services.

RELEASE/WAIVER

As the client, I understand that by signing this agreement the Services pose some risks to my pet(s) and my property and I expressly and willingly agree to assume complete responsibility for any risk of injury that may occur to my pet(s) or any risk of damages that may occur to my property while Brookside Barkery performs the Services. Further, I expressly and willingly agree to assume complete responsibility for any risk of injury that may occur to my invitees on the property of Brookside Barkery caused by my pet(s). I agree to release and hold harmless Brookside Barkery from all liability, including its owners, managers, members, agents/independent contractors, and employees, should my pet(s) become lost, injured, or otherwise harmed in the course of performing the Services; likewise, I release and hold harmless Brookside Barkery should my property suffer any damage in the course of performing the Services by Brookside Barkery, its owners, managers, agents/independent contractors, and employees.

I hereby grant permission for Brookside Barkery to act on my behalf as my attorney-in-fact for my pet(s), and in my pet's best interests, by obtaining veterinary care should Brookside Barkery deem it necessary for the health and well-being of my pet. I agree to pay for and reimburse the cost of any and all veterinary and other reasonably necessary services for my pet(s) which cost may be incurred or borne by Brookside Barkery. Further, I attest that my pet(s) are up-to-date on vaccinations and will provide proof of same to Brookside Barkery. I also attest that my pet does not suffer from any life threatening or contagious conditions that may be exacerbated by exposure to other pets, or my pet would expose other pets to undue risk while in Brookside Barkery's care.

Brookside Barkery agrees to exercise all due and reasonable care to prevent injury, illness, or death to my pet(s) and prevent harm to my property in my absence. However, in the event of illness, injury or death, or damage to my property, except those caused by recklessness or negligent acts on the part of Brookside Barkery, Brookside Barkery shall not be liable for such injury, illness or death of my pet(s) or any damage to my property.

Understanding the risks as stated above, I freely and voluntarily enter into this agreement, including the Release/Waiver, with Barkery & Bath, Inc. and I have given up considerable future legal rights. I am 18 years of age or older and mentally competent to enter into this agreement. This agreement is a full and complete instrument. No other warranties expressed or implied are valid unless stipulated above. I have read this agreement, and release/waiver and understand the contents of this form.
